

Official Rules for The Verge Processor Launch Sweepstakes
No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning.

1. **Eligibility:** **The Verge Processor Launch Sweepstakes** (the “Sweepstakes”) is open to residents of the United States (excluding territories and possessions), who are at least eighteen (18) years of age (or in the case of legal residents of jurisdictions where the age of majority is greater than 18 years of age, such age of majority under the laws of the jurisdiction in which they reside at the time of entry) who have internet access and a valid email address. Employees, independent contractors, interns, officers, directors, and agents of Sponsor, Administrator, other companies associated with the Sweepstakes, as well as the immediate family members (spouse, parents, siblings, and children, and their respective spouses) and household members of any of the foregoing are not eligible to enter. **VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**
2. **Sponsor:** The Sweepstakes is sponsored by Vox Media, LLC, 1201 Connecticut Avenue, 11th Floor, NW, Washington, DC 20036 (“Sponsor”).
3. **Administrator:** Gleam. (“Website Administrator”).
4. **Agreement to Official Rules:** By entering the Sweepstakes, you indicate your full and unconditional agreement to, and acceptance of, (a) these Official Rules and (b) Sponsor’s decisions, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein.
5. **Entry Period:** The Sweepstakes begins at 10:00 AM ET on Friday, January 3rd, 2020 and ends at 10:00AM ET on Friday, January 10th, 2020, (the “Entry Period”). Entries submitted before or after the Entry Period will not be eligible. Administrator’s computer is the official time-keeping device for the Sweepstakes. Entries submitted before or after the applicable Entry Period will not be eligible.
6. **How to Enter** During the Entry Period, visit <https://gleam.io/LiPlj/the-verge-processor-launch-giveaway> (the “Sweepstakes Website”), and complete the official online entry form by filling out your name, email address, and completing the actions detailed on the Sweepstakes Website. You will receive one (1) entry for completing the following action directly from the links on the Sweepstakes Website: subscribing to the Processor newsletter. There is a limit of one (1) Entry per person during the Entry Period. Entries in excess of the allowable limit will not be acknowledged. You may not enter more times than indicated by using multiple e-mail addresses, identities or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules your submission may be removed from eligibility at the sole discretion of Sponsor. The use of an agency or any automated system to enter is strictly prohibited and Sponsor reserves the right to disqualify any entries received through such methods, as determined by Sponsor, in its sole discretion. If you access the Sweepstakes Website on your mobile device to participate in this Sweepstakes, your wireless service provider may charge you for applicable data charges. You should consult your wireless service provider regarding its pricing plans. Message and data rates may apply.

7. **Alternative Method Of Entry.** You may also enter the Sweepstakes and receive one (1) entry without completing any action on the Sweepstakes Website (“E-Mail Entries”). During the Entry Period, e-mail your name, complete address, email address and date of birth to giveaways@theverge.com with the subject line “The Verge Processor Launch Sweepstakes”. E-Mail Entries must be received by Sponsor by the end of the Entry Period. There is a limit of one (1) E-Mail Entry per person who has not entered via the Sweepstakes Website. There is a limit of one (1) total entry per person, and if a person has entered via the Sweepstakes Website and Email Entry, only one (1) entry will be counted.
8. **Drawing:** After the Entry Period, Sponsor will select one (1) potential winner in a random drawing of all entries received. You are not guaranteed to receive a prize, and the odds of being selected depend on the number of entries received.
9. **Notification and Requirements of Potential Winner:** Potential winner will be contacted by email to the account used to enter the Sweepstakes within the day of the drawing. Failure to respond to the initial verification notice within twenty-four (24) hours after notification or return of verification notice as undeliverable after three (3) attempts will result in disqualification; if a potential winner is disqualified, the Sponsor will select an alternate potential winner in his/her place at random from all remaining entries received. Only three (3) alternate potential winners will be contacted. Except where prohibited, a potential winner may be required to complete and return an affidavit of eligibility and liability/publicity release.
10. **Prize(s):** The winner will receive one (1) prize pack filled with gadgets from The Verge (the “Verge Gear Prize Pack” or “Prize”) with a total ARV of \$739.98. **A winner is solely responsible for paying any and all Prize related expenses, including without limitation any and all federal, state, and local taxes, and any and all other costs and expenses not listed above.** Any Prize details not specified above will be determined by Sponsor in its sole discretion. The Prize will be delivered to Winner at an address in the United States as designated by Winner. The Prize may be subject to additional terms and conditions. The Prize (or any individual Verge Gear Prize Pack item) may not be transferred and must be accepted as awarded. You may not request cash or a substitute prize; however, Sponsor reserves the right to substitute a Prize (or one or more Verge Gear Prize Pack item) with another prize of equal or greater value if the Prize (or one or more Verge Gear Prize Pack item) is not available for any reason, as determined by Sponsor in its sole discretion.

The names of companies, products, and logos have been used for identification purposes only and may be the copyrighted properties and trademarks of their respective owners. The mention of any company, or the inclusion of a product or service as a prize, does not imply any association with or endorsement by such company or the manufacturer or distributor of such product or service and, except as otherwise indicated, no association or endorsement is intended or should be inferred.

Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Failure by Sponsor to enforce any term of these Official Rules shall not constitute a waiver of that provision. Proof of sending any communication to Sponsor by mail shall not be deemed proof of receipt of that communication by Sponsor. In the event of a dispute as to any online Entry, the authorized account holder of the e-mail address used to enter will be deemed to be the participant. The “authorized account holder” is the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted e-mail address. The Sweepstakes is subject to federal, state, and local laws and regulations and is void where prohibited.

12. **Release and Limitations of Liability:** By participating in the Sweepstakes, you agree to release and hold harmless Sponsor, Administrator, its parent, subsidiaries, affiliates, and each of their respective officers, directors, employees, and agents (the “Released Parties”) from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of any prize, including, but not limited to: (a) unauthorized human intervention in the Sweepstakes; (b) technical errors related to computers, servers, providers, or telephone, or network lines; (c) printing errors; (d) lost, late, postage-due, misdirected, or undeliverable mail; (e) errors in the administration of the Sweepstakes or the processing of entries; or (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant’s participation in the Sweepstakes or receipt or use of any prize. You further agree that in any cause of action, the Released Parties’ liability will be limited to the cost of entering and participating in the Sweepstakes, and in no event shall the Released Parties be liable for attorney’s fees. You waive the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages, including without limitation, arising out of access to and use of the Sweepstakes Website, and <https://gleam.io>.
13. **Privacy and Publicity:** Please review the terms and conditions governing use of the application before entering the Sweepstakes. Any information you submit as part of the Sweepstakes will be used for purposes of this Sweepstakes and treated in accordance with Sponsor’s [Terms and Conditions](#) and [Privacy Policy](#). By entering the Sweepstakes, entrants further acknowledge and agree that information submitted through the Sweepstakes Website may be collected and shared by Administrator according to the Administrator’s [Terms and Conditions](#) and [Privacy Policy](#). Except where prohibited, participation in the Sweepstakes constitutes an entrant’s consent to Sponsor’s use of his/her name, likeness, voice, opinions, biographical information, and state of residence for promotional purposes in any media

without further payment or consideration. For any privacy concerns or requests, please refer to Sponsor's Privacy Policy.

14. **Disputes:** Except where prohibited, you agree that any and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or any Prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Washington, DC. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, your rights and obligations, or the rights and obligations of Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of Washington, DC, without giving effect to any choice of law or conflict of law rules (whether of Washington, DC or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than Washington, DC.
15. **Third Party Platforms:** By participating in this Sweepstakes, entrants hereby release and agree to hold harmless any third party platform that may be used and its affiliates from any and all liability, loss or damages arising from or in connection with the awarding, receipt, and/or use or misuse of prizes or participation in any prize-related activities. You understand that you are providing your information to the Sponsor and/or Administrator of this Sweepstakes and not to Facebook, Twitter, Youtube, Pinterest, LinkedIn or Google.
