**JOINT STATUS REPORT REGARDING
CONCLUSION OF ARBITRATION**

1 Pursuant to the Parties' Joint Stipulation dated August 3, 2020 (filed August 4, 2020), the
2 Parties hereby submit a joint status report regarding the conclusion of the arbitration proceedings.

3 The Parties participated in the arbitration hearing on September 1-4, 7-11, and 15, 2020, and
4 submitted Post-Hearing Briefs on October 12, 2020. eBay asserted four causes of actions against
5 Defendant Amazon.com, Inc. On November 10, 2020, the Arbitration Panel issued its Final Award.
6 The Final Award found in favor of Defendant Amazon.com, Inc. on all claims.


7 While the Panel concluded that eBay proved the element of breach with respect to five
8 respondents (not including Amazon.com, Inc.), the Panel found that eBay did not prove that it
9 suffered damages as a result. The Final Award denied all of eBay's claims as to all respondents and
10 deemed the respondents the prevailing parties in the arbitration.

11 Amazon.com, Inc. intends to file a Motion to Confirm the Final Award.
