**JOINT STATUS REPORT REGARDING

1 Pursuant to the Court’s prior order (Dkt. 21) and the Parties’ prior Joint Status Report (Dkt.  
2 25), the Parties hereby submit a joint status report regarding the conclusion of the arbitration  
3 proceedings.

4 The Parties participated in the arbitration hearing on September 1-4, 7-11, and 15, 2020, and  
5 submitted Post-Hearing Briefs on October 12, 2020. eBay asserted seven causes of action against  
6 Defendants Boch and Hedger and six causes of action against Defendant Arambula. On November  
7 10, 2020, the Arbitration Panel issued its Final Award. The Final Award found in favor of  
8 Defendants Boch, Hedger, and Arambula on all claims.

9 While the Panel concluded that eBay proved the element of breach with respect to five  
10 respondents (none of which is a Defendant in this action), the Panel found that eBay did not prove  
11 that it suffered damages as a result. The Final Award denied all of eBay’s claims as to all  
12 respondents and deemed the respondents the prevailing parties in the arbitration.

13 Defendants intend to file a Motion to Confirm the Final Award.
