Officers responded to [REDACTED] in response to multiple 911 phone calls in reference a stabbing. Upon arrival, Officers found [REDACTED] (22 years old) lying adjacent to the roadway covered in blood with multiple wounds throughout her back, head and arm. When asked what happened [REDACTED] stated that her brother had stabbed her and her sister was still in the house. [REDACTED] was trauma alerted to Delray Medical Center having two collapsed lungs. Officers then found [REDACTED] (33 years old) in the residence also covered in blood with multiple wounds throughout back, face, arms and hands. [REDACTED] provided a sworn audio/video recorded statement in which [REDACTED] had come to visit their brother Irwing Rivera 02/14/1989 at his residence, [REDACTED] spending the night in his spare room. [REDACTED] advised that they awoke with Irwing repeatedly stabbing them with a knife and she attempted to fight Irwing off as he continued to stab her and [REDACTED] fled the room. [REDACTED] stated that she was eventually able to push Irwing from the room calling police. [REDACTED] was also trauma alerted to DMC

On scene I also made contact with neighbors [REDACTED] who provided audio/video sworn statements advising that they had been awakened by a loud banging at their front door to find a female covered in blood [REDACTED] pleading for help stating, HES TRYING TO KILL ME, PLEASE HELP MY SISTER.. [REDACTED] stated that they opened the door calling police when they then saw their neighbor Irwing walk by also covered in apparent blood who told them to, SHUT THE DOOR and that EVERYTHING IS OK. [REDACTED] advised that Irwing saw [REDACTED] on the phone and then started running east bound towards Federal Hwy. [REDACTED] both identified their neighbor Irwing as Irwing Rivera 02/14/1989 via photograph.

Officers canvassed the area for Irwing with DBPD making contact with him on 01/07/2021 at approximately 0700 hours where upon making contact Irwing spontaneously uttered, I KILLED MY SISTERS.

Irwing was transported to BBPD where he was photographed and changed out of his bloody clothing. In a sworn taped interview, Irwing admitted to stabbing both of his sisters. Irwing said that when he entered his sister's bedroom while they were sleeping and began stabbing them with a, brass knuckle knife. Irwing believed that he killed both of his sisters and said that he did so because it was his purpose, which he was told to by a higher power.

Due to the totality of events Irwing was placed under arrest for Attempted Murder X2
