**NARRATIVE**

Event #01915 This is a bwc incident. In summary r/o's were dispatched to a 10-1 at above listed location. Upon arrival, r/o's observed multiple victim's shot. R/o's spoke to P.O Rhodes #7070 who related to r/o's, he observed 2 male blacks shooting north-west into a crowd of people. Rhodes related both offenders fled south-bound behind the Lems BBQ restaurant rear through the parking lot and into the south alley. Offender #1 was described as a male black wearing a black t-shirt thin built, offender #2 was described as a male black wearing a dark jacket with white stripes on his sleeves and dark pants. R/o' observed three victims across the street located in the alley of 7449 S prairie. [V] MILES, KIMFIER was located at 305 E 75th street with GSW to the left arm, right breast and was transported to University of Chicago by ambulance #1 and was pronounced deceased by [REDACTED] at 02:45hrs. One firearm was recovered in purse next to the victim by evidence technician. Medical examiner was notified (Flowers#88). [V] [REDACTED] was transported to St. Bernard hospital by ambulance #75 with a GSW to the left foot and is under the care of [REDACTED] in stable condition. [V] [REDACTED] was transported to Northwestern hospital by ambulance#14 with a GSW to the buttocks, middle finger, and ring finger and is under the care of [REDACTED] in stable condition. [V] [REDACTED] was transported to NorthWestern by ambulance#50 with two GSWs to groin area and is under the care of Dr. [REDACTED] and is in stable condition. [V] [REDACTED] was transported to University of Chicago by ambulance #1 with a GSW to the right hand, right lower leg, and left knee under the care of [REDACTED] in stable condition. [V] [REDACTED] was transported to South Shore hospital by ambulance#55 with a GSW to the right ankle and is in stable condition under the care of [REDACTED]. [V] [REDACTED] was transported to Jackson park by a third party with a graze GSW to the left ankle and is in stable condition under the care of [REDACTED]. [V] [REDACTED] was transported by a third party with a GSW to the right arm, left leg, and graze GSW to the chest under the care of [REDACTED]. [V] [REDACTED] was transported to Jackson park hospital by a third party with a GSW to the left upper arm, and left shoulder in stable condition under the care of [REDACTED]. [V] [REDACTED] was transported to University of Chicago hospital by ambulance #29 with a GSW to the right ankle and under the care of Dr. [REDACTED] in stable condition. Victims were given Vin. R/o's were later notified that there could possibly be another victim that was self transported under a third party per Tactical unit that was on scene. Tactical officers advised the zone that the possible victim got into a white range rover fled in an unknown direction. R/o's were unable to find out any local hospital with this possible victim. R/o's were unable to determine if the possible victim had actually been shot or confirmed any injuries. R/o's located a crime scene at 311 E 75th street consisting of approx. 16 shell casings and multiple bullet fragments. Shot spotter incident #306-158427 recorded fourteen gun shots at 320 E 75th street.
