1 MADIGAN: Hi Mike.  
2  
3 McCLAIN: Hi Michael. So I just wanna let you know that I sent an  
4 email to Lou Lang, uh he's called me cause he's curious  
5 about wh, what he's doing with these checks that he'll  
6 be glad to do it but uh none of them have really races,  
7 so I cleared up all that. And so he said, "At the end

9 chatter." But um, he's gonna send out those checks

12 MADIGAN: Okay. Uh is he, was he gonna mail (unintelligible)  
13 committees?

17 MADIGAN: Okay. Alright, anything else?

19 McCLAIN: Nope. I just wanted to let you know.

21 MADIGAN: Now, you've got a phased program with this guy right,  
22 too?  
23  
24 McCLAIN: Right, right.  
25  
26 MADIGAN: Yeah.

28 McCLAIN: I do.  
29  
30 MADIGAN: Mike i-, if you think I'm wrong tell me I'm wrong but  
31 I, I don't see how he continues down there.

33 McCLAIN: Um, Mike I, I don't wanna talk out of school here but  
34 um, um, Heather, when I'm, I'm talking to Heather quite

35 a bit about how to um move him to the dark side, that's  
36 what I call lobbying.

38 MADIGAN: Mhm.

40 McCLAIN: And, so I talk to her a lot. And so I talked to her this  
41 week and she said that there was a woman that wants to  
42 um, does not want to go public on Lou but is going to  
43 tell Lou that if he ends up being in leadership again  
44 she will go public.

46 MADIGAN: Mhm.  
47  
48 McCLAIN: And that lady was gonna call Lou.  
49  
50 MADIGAN: Mhm. Yeah, okay.

52 McCLAIN: So I, no I mean-

54 MADIGAN: Mhm.

56 McCLAIN: Uh that, that, that, we'll see how he reacts to that  
57 and I'll have leather, Heather follow up to make sure  
58 that woman makes that call.

60 MADIGAN: Yeah.

62 McCLAIN: But, but um, n, no I'm, I, uh, uh, I, I have a phase in
