

Official Rules for the Bent Musket Great Football Gear Giveaway

No Purchase Necessary. A Purchase will not Increase Your Chances of Winning.

- Eligibility:** The **Bent Musket Great Football Gear Giveaway** (the “Giveaway”) is open only to legal US residents who are at least eighteen (18) years of age who have a Twitter account. Employees, independent contractors, interns, officers, directors, and agents of Sponsor, other companies associated with the Giveaway, as well as the immediate family members (spouse, parents, siblings, and children, and their respective spouses) and household members of any of the foregoing are not eligible to enter. **VOID IN ANY LOCATION WHERE PROHIBITED OR RESTRICTED BY LAW.**

- Entry Period:** The Giveaway begins at 12:00:01 PM ET on April 21, 2016 and ends at 11:59:59 AM ET on April 21, 2016 (the “Entry Period”). Entries submitted before or after the Entry Period will not be eligible. Sponsor’s computer is the official time-keeping device for the Contest. Entries submitted before or after the applicable Entry Period will not be eligible. Sponsor’s computer is the official time-keeping device for the Giveaway.
- How to Enter:** During the Entry Period, an entrant must first visit Twitter.com, log into his/her Twitter account and follow the Sponsor’s Twitter profile “www.twitter.com/thebentmusket” (“Sponsor’s Account”) (if he/she does not follow it already). Sponsor will publish a specified tweet announcing the Giveaway. You may enter the Giveaway by re-tweeting the specified tweet on Twitter.com, along with the hashtag **#greatfootballgear**, **#sweeps**, and **tagging @thebentmusket** (the “Entry Hashtag”). A response tweet will be deemed ineligible if it does not contain everything contained in the Entry Hashtag. By retweeting the specific post, with the Entry Hashtag, you will obtain one (1) entry into the Giveaway. There is a limit of one (1) entry per person/Twitter account during the Entry Period. An entrant must have a non-private Twitter account to enter the Giveaway and continue to follow @thebentmusket and maintain such non-Private Twitter account for at least two (2) days after the Entry Period ends for winner notification purposes. Entrants having multiple Twitter accounts will be disqualified. Additional Entries will not be acknowledged. The use of an agency or any automated system to enter is strictly prohibited and Sponsor reserves the right to disqualify any entries received through such methods, as determined by Sponsor, in its sole discretion. You must be a registered member of Twitter to participate. Registration is free. **This Giveaway is in no way sponsored, endorsed, or administered by, or associated with Twitter.**

If you access Twitter on your mobile device to participate in this Giveaway, your wireless service provider may charge you for applicable data charges. You should consult your wireless service provider regarding its pricing plans. Message and data rates may apply.

6. **Drawing:** After each Entry Period, Sponsor will select two (2) potential winner(s) and (the “Winners”) in a random drawing of all entries received. The odds of being selected depend on the number of entries received.

7. **Notification and Requirements of Potential Winners:** Sponsor will notify the potential Winners by sending a congratulatory “Tweet” to the entrant’s Twitter account. Sponsor will then ask, the entrant to provide, via Direct Message, the Winner’s name, address and date of birth. Sponsor will attempt to notify potential Winners within two (2) business days of the drawing. If a potential Winner does not respond within one (1) business day after the notice is sent, the Sponsor will select an alternate potential Winner in his/her place at random from all remaining entries received. Only three (3) alternate potential Winners will be contacted for each Prize. Except where prohibited, a potential Winner may be required to complete and return an affidavit of eligibility and liability/publicity release. If a potential Winner fails to sign and return these documents within the required time period, an alternate potential Winner may be selected in his/her place in a random drawing of all remaining entries received.

Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Giveaway or to be acting in violation of these Official Rules or in an

unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Giveaway may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Failure by Sponsor to enforce any term of these Official Rules shall not constitute a waiver of that provision. Proof of sending any communication to Sponsor by mail shall not be deemed proof of receipt of that communication by Sponsor. In the event of a dispute as to any online entry, the authorized account holder of the e-mail address used to enter will be deemed to be the participant. The “authorized account holder” is the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted e-mail address. The Giveaway is subject to federal, state, and local laws and regulations and is void where prohibited.

12. **Disputes:** Except where prohibited, you agree that any and all disputes, claims and causes of action arising out of, or connected with, the Giveaway or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Washington, DC.
